General Information Clause on Personal Data Processing

- 2. Your personal data will be processed in accordance with GDPR, i.e.:
 - a) based on Article 6 (1) (b) GDPR (to the extent that you are a party to this contract):
 - i) for the purpose of performance of:
 - the contract concluded with the Controller (including for: sending invoices, contact with information about the service),
 - the contract concluded with the Controller for the provision of electronic services and the provision of such electronic services, in connection with the use of the Controller's website (as a registered or unregistered user) or services that require authorization by creating a user profile or services that require that the user is granted access to the Controller's service, or services that require Subscription, save that processing on the above basis may also relate to the completion of the complaint procedure,

- d) based on Article 6 (1) (a) GDPR (for ordinary data), i.e. based on your consent, i.e. for the following purposes:
 - i) informing you about services, products and events with the participation of the Controller or its personnel,
 - ii) your participation in promotional campaigns,
 - ii) your participation in competitions,
 - iv) market research by the Controller,
 - v) sending you commercial and marketing information of the Controller, including that tailored to your individual needs and preferences, which includes profiling,
 - vi) advertising by the Controller of its services and goods, including via email.
 - vii) analyzing your behaviour and preferences with the intended use of the results of these tests for the purposes of improving the quality of services provided by the Controller, including based on profiling,
 - viii) profiling your personal data.
- 3. In certain circumstances, the Controller has the right to transfer your personal data to other recipients, if it is necessary to perform the contract concluded with you or to fulfil the Controller's obligations or to achieve the purpose of processing. In such case, we will transfer personal data to three groups of recipients: persons authorized by us, our employees and co-workers on the "need-to-know" basis, processors, including those operating within the Group, entrusted with the processing of personal data and other data recipients, e.g. postal service providers, telecommunications service providers, couriers, banks, financial service providers,

insurers, law firms or other Group companies, competent Authorities.

- 4. The Controller processes the following categories of your personal data:
 - a) if: the User is not a User registered on the Website or in the Service, the User has not been provided with files, the User has not submitted a request to use the Service, has not submitted a Complaint, or has not made contact in any other way, the processing will or may cover:
 - Ordinary Personal Data, i.e.: IP number, device data, browser data, data collected in cookies, identification of termination of the telecommunications network or IT system, information about the start, end and scope of each use of the Service provided electronically, information about the Services provided electronically used by the Customer, information about the content viewed by the Customer on the website, pixel image of the website, name of the Service provider.
 - b) additionally if: the User is a User registered on the Website or in the Service or the User has been provided with files, the User has submitted requests to use the Service, the User is a party to a contract with the Controller other than for the provision of electronic services, the User has submitted a Complaint, the User has made contact in any other way, the processing will or may additionally cover:
 - Ordinary Personal Data, i.e. First name, last name, address and place of residence, correspondence address, business address, electronic address of the Service Recipient, phone number, VAT number, PESEL (personal identification number), ID card number and series, login, information about the services provided electronically used by the Service Recipient, image.
- 5. Your personal data will be transferred to a third country, i.e. the USA. The transfer of Personal Data to a Third Country will take place on the terms resulting from article 46 GDPR, in particular on the basis of standard contractual clauses.  - your use of services provided electronically, but not longer than until the date of raising an objection,
 - marketing of the Controller's goods and services, but not longer than until the date of deletion of the subscription on a social network portal or the date of raising an objection,
 - for the period necessary to ensure the protection of persons or property owned by the Controller, but not longer than until the date of raising an objection,
 - for the period necessary for determining, pursuing or defending claims, but not longer than until the date of limitation of claims or the

- date of raising an objection,
- the period necessary from the point of view of the purpose for which your contacted the Controller, but not longer than until the date of limitation of claims or the date of raising an objection,
- the period of audits and inspections carried out, but not longer than until the date of raising an objection or limitation of claims,
- the period of operation of cookies, i.e. until they are deleted, but not longer than until the date of limitation of claims or the date of raising an objection,
- the period of performance of a contract with Business Partners, but not longer than until the date of raising an objection or limitation of claims,
- handling complaint procedures, but not longer than until the date of limitation of claims or raising an objection,
- configuring and managing the User's account, but not longer than until the date of limitation of claims or raising an objection,
- d) section 2 d) will be stored for the period of:
 - the Controller's sending you information, commercial or marketing content, including via the website, or until withdrawal of your consent,
 - the Controller's informing you about services, products, events with the participation of the Controller or its personnel (commercial information), however not longer than until withdrawal of your consent,
 - your participation in promotional campaigns, but not longer than until withdrawal of your consent,
 - your participation in competitions, but not longer than until withdrawal of your consent,
 - market research by the Controller, but not longer than until withdrawal of your consent,
 - the Controller's advertising its services and goods, but not longer than until withdrawal of your consent,
 - analysing your behaviour and preferences, but not longer than until withdrawal of your consent.
- 7. You have the right to request the Controller to provide you with access to your personal data, rectify it, delete it, limit processing and transfer the data. The request can be made in person, by post, by phone, via e-mail.
- 8. You have the right to withdraw your consent at any time by sending a statement of withdrawal of consent, without affecting the lawfulness of the processing that was carried out on the basis of consent before its withdrawal. Your right may be exercised in person, by post, via e-mail or by phone.
- 9. You have the right to object to the processing specified in section 2 c)regarding the processing of personal data for the purpose of legitimate interests pursued by the Controller, however the right to object cannot be exercised where there are valid legitimate grounds for the processing, which override your interests or fundamental rights and freedoms, in particular for determining, pursuing or defending claims. The objection can be made in person, by post, by phone, via e-mail.
- 10. You have the right to complain against the Controller's activities to the President of the Office for Personal Data Protection, ul. Stawki 2, 00-193 Warsaw
- 11. Providing personal data referred to in:
 - section 2 a) is voluntary but is a contractual requirement and is necessary for the performance of the contract (if you are a party to it), and failure to provide personal data will prevent the performance of the contract or the use of services,
 - b) section 2 c) it is voluntary:

- but if you are a party to the contract, it is a contractual requirement and is necessary for the performance of the contract concluded with you, and failure to provide personal data will prevent the performance of the contract or the use of services,
- save that for cookies, providing data is a contractual condition, but failure to provide data will not prevent the performance of the contract and the use of services, although it may limit their functionality,
- save that for complaint procedures, providing data is a contractual or statutory requirement, and failure to provide data will prevent the examination of a complaint,
- save that for processing in order to contact the Controller, providing contact personal data is a condition for contacting the Controller, and failure to provide data will prevent your contact with the Controller,
- save that for marketing of the Controller's goods and services, the processing of personal data is voluntary and is not a condition for the conclusion of the contract, and failure to provide will make it impossible to inform you about the Controller's services and products,

12. Your personal data has been obtained:

- d) from your employer / associate if you have not concluded a contract with the Controller other than the contract for the provision of electronic services, or you take actions to conclude such a contract,
