According to Article 13 (1) and (2) of Regulation (EU) No 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation, hereinafter GDPR) (OJ EU L119/1), please be advised that:

- 1. The Controller of your personal data is Sarzyna Chemical Sp. z o.o. with its registered office at ul. We work on business days from Monday to Friday from 7.00 to 15.00 hrs.
- 2. Your personal data will be processed in accordance with GDPR:
 - in order for the Controller to contact you via the contact form on the Controller's website or by e-mail or by phone, in connection with your inquiry, as well as to protect the website from the operation of bots, where the basis for processing will be a legitimate interest of the Controller based on Article 6 (1) (f) GDPR, consisting in contacting those using the contact form on the Controller's website or making contact with the Controller by other means, including via e-mail, answering customer inquiries and comments, and marketing of goods and services of the Controller, website security and services of the Controller,
 - b) based on Article 6 (1) (f) GDPR (for ordinary data), i.e. based on your consent, i.e. to apply appropriate safeguards against the activities of bots, including the use of reCAPTCHA security measure, as well as for statistical purposes.
- 3. Your personal data will be transferred to a third country, i.e. the USA. The data will be properly protected based on the privacy shield certificate used by the recipients of the data. The transfer will be made in connection with the use of Google Analytics and Google Recaptcha by the Controller.
- 4. Your personal data indicated in section 2 above will be stored for the period necessary from the point of view of the purpose for which you contacted the Controller, for section 2a not longer than until the date of raising an objection, and for section 2 b not longer than until the date of withdrawal of consent.
- 5. In certain circumstances, the Controller has the right to transfer your personal data to other recipients, if it is necessary to achieve the purpose of processing. In such case, we will transfer personal data to three groups of recipients: persons authorized by us, our employees and co-workers on the "need-to-know" basis, processors entrusted with the processing of personal data and other data recipients, e.g. postal service providers, couriers, banks, insurers, law firms, e-mail service providers, and telecommunications service providers.
- 6. You have the right to request the Controller to provide you with access to your personal data, rectify it, delete it, limit processing and transfer the data. The request may be filed in person, by post or via email.
- 7. You have the right to object to the processing specified in section 2 regarding the processing of personal data for the purpose of legitimate interests pursued by the Controller, however the right to object cannot be exercised where there are valid legitimate grounds for the processing, which override your interests or fundamental rights and freedoms, in particular for determining, pursuing or defending claims. Your right may be exercised in person, by post or via e-mail.
- 8. You have the right to withdraw your consent at any time by sending a statement of withdrawal of consent, without affecting the lawfulness of the processing that was carried out on the basis of consent before its withdrawal. Your right may be exercised in person, by post, via e-mail or by phone.

- 9. You have the right to complain against the Controller's activities to the President of the Office for Personal Data Protection, ul. Stawki 2, 00-193 Warsaw
- 10. Providing your personal data referred to in section 2 above is voluntary and is not a statutory or contractual requirement or a precondition for concluding a contract, but failure to provide the same prevents contact with the Controller. As regards the use of statistical tools by the Controller, providing data is fully voluntary is not a precondition for performing a contract and you are not obliged to provide this personal data.
- 11. No actions will be taken in relation to you, which would involve automated decision making, including profiling. However, the Controller will use profiling.
